(all lights must be out by 9:45pm)  
**Tear Down:** July 2 by Noon

You must check in with officials upon arrival for your space assignment. Self-contained RV spaces are limited; a list of local accommodations can be found at [www.grandcouleedam.org/stay.html](http://www.grandcouleedam.org/stay.html). Power hook-ups are for the Food vendors and not for RV use; there are limited power hook-ups for Arts & Crafts vendors. Bring your own hoses, extension cords and adapters. Food vendors must have a current health permit from Grant County, WA.

**Pricing:** **Arts & Crafts Vendors: Space 15' x 15' @ \$125 each**  
**Food Vendors: Space 15' x 15' @ \$150 each + 10% daily gross**  
(10% must be paid before leaving the park, no exceptions!)

**ALL VENDORS:** Please send a description of the items you will be selling and a photo of your booth. We have the right to refuse your application if we already have too many of the same type of vendors or if you have not adequately described what you will be selling. Attach your description and booth photo to this application. No guns, knives, alcohol, or any offensive items are allowed. Include a self-addressed, stamped envelope if you would like your photo returned. Your check will only be deposited if you are accepted. No refunds due to weather or changes in personal plans. REMEMBER THAT THE VISITOR CENTER PARK DOES NOT ALLOW DOGS!
